Subject: Departmental Examination for Executive Engineers, Assistant Executive Engineers, Assistant Engineers and Junior Engineers/S.O. & A.D. (Hort.) to be held from 02.02.2009 to 06.02.2009.

The next Departmental Examination in Accounts etc. for Junior Engineers, Assistant Engineers/ Assistant Executive Engineers and Executive Engineers will be held from **02.02.2009 to 06.02.2009 (Annexure-I)**.

2. All the Superintending Engineers are requested to advise all the officers (attached to their circles) who have not yet passed the prescribed Examination that they should take up the forthcoming examination positively.

3. In accordance with instructions contained in Directorate's O.M. No.23/4/84-EC-I dated 14.4.1984 regularly promoted Assistant Engineers having 10 years service in the grade may also be allowed to appear in the Departmental Examination meant for Executive Engineers, if they so desire.

4. In accordance with instructions contained in Directorate's O.M. No.A-34001/1/91-EC-VI, dated 25.7.1991 Junior Engineer's (Civil/Elect.) having 10 years regular service in the grade may also be allowed to appear in the Departmental Examination in Accounts meant for Assistant Engineers, if they so desire.

5. A list showing the names of Officer-in-charge of the Examination centers and the areas covered by each center is also attached (Annexure-II). The candidate can be paid T.A. as admissible under the rules. Examinees should send their application (in duplicate) latest by **29.12.2008** to the **Officer-in-charge of Examination Center** nearest to their place of duty indicating their names, designation, post to which attached and complete address. **They should clearly state the paper in which they want to appear and mention separately the papers in which they have already been granted exemption indicating the Roll No., Year of passing the examination and the number and date of this office reference for verification. An attested copy of the office reference may also be sent. The Proforma for application is enclosed (Annexure-III).**

6. The Officer-in-charge of Examination Centres should allot Roll Numbers to all the candidates for their respective centers as indicated in Annexure-II. The candidates who are not borne on the cadre of CPWD and have been sponsored by other Department to sit in the above examination on payment of prescribed fee, the Roll Numbers are to be allotted showing the catch words of the sponsoring Department such as D(I.I.T.)-15, C(AIR)-10 etc. They will prepare list of examinees for their centers and furnish the same alongwith the copy of application received from them to this office on or before **09.01.2009** showing the Numbers of Question Papers required by them for each

category of officers separately. (The number of question papers meant for Civil and Electrical Engineering for AEEs/Direct Recruit Class-II AEs should be intimated separately). **Their requirements of Question Papers must reach this office latest by 09.01.2009. No request or demand for additional Question Papers will be entertained after the said date. The Question Paper will be dispatched to them soon thereafter.**

7. The candidate will have the option to answer the Question Paper(s) in Hindi. The answering of a Question Paper partly in Hindi and partly in English will not be permitted. The option once exercised by the candidates in this regard will be final and they will not be permitted to withdraw it. It may, however, be made clear that it will not be possible to make available Hindi translation of all the codes and Manuals and other literature for reference for answering relevant Question in Hindi. The Officer-in-charge of the Examination center are requested to forward to this office the name of such candidates who opt to answer in Hindi.

8. The candidates other than those borne on the Central PWD cadre have to pay the examination fee of Rs.100/-(One hundred only) per paper in which they intend to appear. The Officer-in-charge of the Examination center may accept their application alongwith the examination fee only. The amount when received may be remitted to the Government Treasury under the Head of Accounts 0059-Public-Works other Receipt (Examination fee).

9. Instruction for return of answer book will be issued separately alongwith the dispatch of Question Papers to each Officer-in-charge. The receipt of this Memo may please be acknowledged.

10. It may please be noted that no request for change of Controller of Examination will be entertained.

11. The copy of the notification alongwith the application form can be down loaded from the CPWD Web Site www.cpwd.nic.in or it can be obtained from the Officer-in-Charge of the examination centre.
