

PRE QUALIFICATION NOTICE FOR IMPLEMENTATION OF ERP SOLUTION IN THE CENTRAL PUBLIC WORKS DEPARTMENT

CPWD desires to carry out integrated computerization to manage the information needs of the department using a technically suitable 'Commercial off the Shelf' (COTS) ERP Application Package which can be implemented rapidly in a time bound manner. The solution being sought by CPWD, which it proposes to host on NIC servers, must have the following modules namely Project Management, Project Resource Management, Project costing, planning & budgeting, Financial Accounting & Management, Project Contract Management, Services Procurement and Materials Management-purchasing & inventory, Human Resource Management, Training & learning Management, Payrolls, E-Tendering, Maintenance Management, Business Intelligence with Key Performance Indicators, Ad-Hoc analytical capabilities, Collaboration services which will include E-mail, document management, messaging etc.

Expression of Interest (EOI), on behalf of President of India is invited from reputed companies/joint ventures, consortiums who possess minimum criterion as specified below. In case of JV the criterion will be applicable to the lead partner.

1. Company must be ISO 9001:2000 and SEI CMM Level 5 certified.
2. Company must be certified implementing partner of leading ERP solution providers such as SAP, ORACLE or any other similar reputed provider
3. Company must have at least five years experience in implementing ERP solutions in large environments.
4. Company must have successfully implemented at least 3 ERP projects, in Govt. Departments/Semi Govt. organizations, PSUs, at least one of which should be having 1000 users, during the last 3 financial years.
5. Annual financial turnover of the company, from software development and implementation, should have been at least Rs. 500 crore in each of the three preceding financial years ending March 31, 2006.
6. Company must have its own development & training centers in at least 3 metropolitan cities and be capable of providing training to CPWD staff
