<u>Name of Work</u>: Up gradation, renovation & new construction at Indira Gandhi Stadium Complex for Commonwealth Games 2010. SH: Improvement of Roof Truss, Roofing, Replacement of Bearings & providing and Installation of Sports Lighting including lighting of spectator galleries.

2. Contractors who fulfill the following initial eligibility requirements separately shall be eligible to apply. **Joint Ventures are not accepted.**

a) Should have satisfactorily completed at least two similar works each costing not less than **Rs 10 Crore** or one similar work costing not less than **Rs 15 Crore** during last seven years ending last day of the month previous to the one in which the tenders are invited.

Similar works shall mean the work of fabrication & erection of steel structure with roofing in industrial (erection height 15 metre and above) / bridge / airport / shipyard / stadium / sports arena etc.

For this purpose 'cost of work' shall mean gross value of the completed work including the cost of material supplied by the Government/client, but excluding those supplied free of cost. This should be certified by an officer not below the rank of Executive Engineer/Project manager or equivalent.

- b) Should have an annual financial turnover of minimum **Rs. 15 crore** for each of the last three years ending 31st March 2007.
- c) Should not have incurred any loss in more than two years during the last five years ending 31st March 2007.
- d) Should have a solvency of **Rs. 15 Crore** certified by Banker as on date.
- e) The applicant contractor has to associate specialized agency(s) for
- (i) Supply and/or replacement of bearings for which the requisite details are required to be furnished in technical bid and
- (ii) Providing & Installation of sports lighting including lighting of spectator galleries for which also the requisite details are required to be furnished in technical bid.

3. Desirous contractors may obtain tender documents on request in writing from the Executive Engineer, Commonwealth Games Division-IV, CPWD, New Delhi on payment Rs. 1500/- in cash up to **4.00 PM on 02.08.2007**.

4. The contractors fulfilling above criteria mentioned at 3(a) to (e) may submit the tender documents along with the **Earnest Money of Rs. 63 lakh** in the form of Receipt Treasury Challan / deposit at call receipt of a scheduled bank / Demand Draft of a scheduled bank issued in favour of the Executive Engineer, Commonwealth Games Division IV, CPWD, New Delhi. (The part earnest money of Rs. 30 lakh may be deposited in the form of Bank Guarantee also. In that case the part earnest money of Rs. 33 lakh will have to be deposited in shape prescribed above).

5. The initial eligibility criteria shall be evaluated first and each of above criteria shall be fulfilled individually. The technical proposal of only those eligible contractors fulfilling these criteria mentioned above shall be opened and evaluated. The financial bid of only those contractors who have fulfilled the minimum eligibility criteria mentioned in the evaluation of technical proposal will be opened in the presence of their representatives on the date and time to be intimated in writing.

6. The pre-bid meeting will be held on **10.08.2007 at 11:00 AM** in the office of the Superintending Engineer, Commonwealth Games Circle-II, C.P.W.D., MDC National Stadium, Mathura Road, New Delhi-110 001.

7. The tender documents are to be submitted in two envelope system. The envelope no. 1 shall contain **Earnest Money along with Technical Bid** (both in different individual envelopes and then these envelopes are to be put in envelope no. 1. The other envelope no. 2 shall have **Financial Bid**. Technical Bid should be in three parts – (a) Initial eligibility criteria including details & credentials of associates (b) Technical details regarding erection methodology of trusses, roofing sheets and proposed methods of dismantling, retrofitting, replacement of bearings and erection procedure and (c) Technical bid for sports lighting. **Technical bids having valid Earnest Money shall only be evaluated.** These two envelopes shall then be placed and sealed in one envelope and submitted. The tender documents completed in all aspects shall be received up to **3:00 PM on 21.08.2007** and technical proposal will be opened at **3:30 PM** on the same day in the presence of the intending bidders/their representatives by EE, Commonwealth Games Division-IV, CPWD.

8. If any information furnished by the applicant is found incorrect/false at a later stage, he shall be liable to be debarred from the tendering/taking up works in CPWD.

9. The department reserves the right to reject any or all prospective application without assigning any reason and to restrict the list of pre-qualified contractors to any number deemed suitable by it, if too many applications are received satisfying the basic pre-qualification criteria.
