Sub: Non-publishing of transfer/posting orders of CPWD Officers in CPWD's Web site Sir,

This is to bring to your kind notice that the transfer/posting orders of CPWD officers, particularly those of the Chief Engineers (both Civil & Electrical) are not being published in the web site of CPWD although as per the standing instructions of the Ministry of Urban Development, all transfer/posting orders of CPWD officers should invariably be published in the web site of CPWD immediately after their issue by the competent authorities. A few such examples of transfer/posting orders of CPWD Chief Engineers which were not published in the web site are given below:

1. Transfer/posting orders of Chief Engineers (Elec.) namely Sri Ashim Sinha from Siliguri to Kolkata, of Sri K.K. Sharma from Chennai to Delhi and Sri R.K. Shingal to Siliguri.
2. Transfer/posting orders of Sri A.K. Shingal, Chief Engineer (Civil) from FWD, Delhi to Kolkata and its subsequent cancellation (if any).
3. Transfer/posting orders of Sri Suresh Kumar, Chief Engineer (Civil) to CSQ
4. Transfer/posting orders of Sri Virender Sharma, Chief Engineer (Civil) to Project Team, Mumbai
5. Transfer/posting orders of Sri S.M. Anrit, Chief Engineer (Civil) from CSQ to NDZ-II

The matter was personally discussed with Sri A.P. Singh, CE(P&S), CPWD and Sri V.K. Sharma, Director (S&D), CPWD. Whereas CE(P&S) intimated that it is the responsibility of the S&D unit to put the orders on the web site, Director (S&D) indicated that he only put those orders on the web site, which are endorsed to him. It thus appears that there is a communication gap between CE(P&S) and Director (S&D) of CPWD resulting the Non-publishing of transfer/posting orders of CPWD Officers in CPWD's Web site.

It is therefore requested to kindly issue suitable instructions to all concerned to ensure publishing of all the transfer/posting orders of CPWD Officers in CPWD's Web site immediately after their issue by the competent authorities.
