**OFFICE ORDER**

**Sub: - Suspension from bidding in CPWD tenders for a period of one year in respect of A.G. Enterprises.**

Whereas a tender was invited by the Executive Engineer, Allahabad, CPWD, Kendriya Sadan, 34-A, M.G. Marg, Civil Lines, Prayagraj (UP)-211001, vide NIT No. 13/EE/ALLAHABAD/2021-22 for the work of "A/R & M/O to AGUP, Allahabad (SH: - Providing Services of worker for Running Day to Day Maintenance of AGUP, RVTI, Allahabad".

Whereas the above tender was opened on 10.08.2021 and the lowest bidder was A.G. Enterprises, 1A, Pocket 1, DDA Flat, Sector-10, Dwarka, New Delhi- 110075.

Whereas A.G. Enterprises, 1A, Pocket 1, DDA Flat, Sector-10, Dwarka, New Delhi- 110075 had submitted Earnest Money Deposit (EMD) Declaration along with their tender, which states that :

*"(1) If after the opening of tender, I/we withdraw or modify my/our bid during the period of validity of tender (including extended validity of tender) specified in the tender documents*

*Or*

*(2) If, after the award of work, I/we fail to sign the contract, or to submit performance guarantee before the deadline define in the tender documents,*

*I/we shall be suspended for one year and shall not be eligible to bid for CPWD tenders from date of issue of suspension order."*

Whereas while the acceptance of tender was in process and during the period of validity of tender, A.G. Enterprises vide their letter number AGE/2021-22/323 dated 11.08.2021 addressed to the Executive Engineer, Allahabad, CPWD, Prayagraj (UP)-211001 requested for cancellation of their participation in tender, amounting to withdrawal of their tender during the period of validity of tender.

Whereas a notice was issued to A.G. Enterprises vide letter number CSQ(CM)/5(1)/Debar/2021/682 dated 08.09.2021 to show cause why action for suspension from bidding in CPWD tenders for a period of one year should not be taken against them on account of violation of EMD declaration.



Whereas the reply submitted by A.G. Enterprises vide their letter number AGE/2021-22/258 dated 09.09.2021 has been considered carefully and has not been found satisfactory.

Therefore I, Vinayak Rai, Chief Engineer(CSQ), CPWD, Nirman Bhawan, New Delhi hereby suspend A.G. Enterprises, 1A, Pocket 1, DDA Flat, Sector-10, Dwarka, New Delhi- 110075 from bidding in CPWD tenders for a period of one year from the date of issue of this order.
