**OFFICE ORDER**

**Sub: - Suspension from bidding in CPWD tenders for one year in respect of M/s GMS Elegant Builders India Private Limited**

Whereas a tender was invited by the Executive Engineer, CCD, CPWD, Coimbatore , vide NIT no. 12/CE/CCD /2021-22 for the work of "Construction of 100 bedded ESI Hospital Building and 32 Nos. Residential Quarters (Ty-IV Spl-2 Nos., Ty-IV -6 Nos., Ty-III -8 Nos., Ty-II-16 Nos.) including development and bulk services, Internal water supply, sanitary installation, internal roads, storm water drains, UG sump, STP-100 KLD, ETP-20 KLD and IEI & Fans, Street lighting, pump sets, substation, DG set, Passenger cum stretcher lifts, CCTV System, Fire Alarm System & PA system, IP based PBX System, Fire Alarm System, LAN System, UPS System, Solar Water Heating system, centralized AC System and Building management system for ESIC at Tiruppur, Tamilnadu"

Whereas the financial bids of the above tender was opened on 23.08.2021 and the lowest bidder was M/s GMS Elegant Builders India Private Limited, New H-98/1, Periyar Nagar, Erode- 638 001, Tamil Nadu.

Whereas M/s GMS Elegant Builders India Private Limited ,New H-98/1, Periyar Nagar, Erode- 638 001, Tamil Nadu had submitted Earnest Money Deposit (EMD) Declaration along with their tender, which states that :

"(1) If after the opening of tender, I/we withdraw or modify my/our bid during the period of validity of tender (including extended validity of tender) specified in the tender documents,

Or

(2) If, after the award of work, I/we fail to sign the contract, or to submit performance guarantee before the deadline in the tender documents,

I/we shall be suspended for one year and shall not be eligible to bid for CPWD tenders from date of issue of suspension order."



Whereas while the acceptance of tender was in process and during the period of validity of tender, M/s GMS Elegant Builders India Private Limited vide their letter number GMSEBPL/TENDER/HO/2021-22 dated 25.08.2021 addressed to the Executive Engineer, CCD, CPWD, Coimbatore, withdraw their bid during the period of validity of tender.

Whereas a notice was issued to M/s GMS Elegant Builders India Private Limited vide letter number CSQ(CM)/5(1)/Debar/2021/679 dated 08.09.2021 to show cause why action for suspension from bidding in CPWD tenders for a period of one year should not be taken against them on account of violation of EMD declaration.

Whereas the reply submitted by M/s GMS Elegant Builders India Private Limited vide their letter number GMSEBPL/TENDER/HO/2727/2021-22 dated 16.09.2021 has been considered carefully and has not been found satisfactory.

Therefore I, Vinayak Rai, Chief Engineer(CSQ), CPWD, Nirman Bhawan, New Delhi hereby suspend M/s GMS Elegant Builders India Private Limited, New H-98/1, Periyar Nagar, Erode- 638 001, Tamil Nadu from bidding in CPWD tenders for a period of one year from the date of issue of this order.
