Sub: Debarment of M/s IDN & Sons, enlisted in Class-II (B&R category), for a period of six months from the date of issue of this order.

Whereas, M/s IDN & Sons is an enlisted Class-II, Buildings & Roads category CPWD contractor vide Enlistment Order No. 15/2023 issued vide letter No. 25(13)/ADG(PRD)/ 2022/134 dated 12.01.2023 and M/s Aayan Construction Company is an enlisted Class-III, Buildings & Roads category CPWD contractor vide Enlistment Order No. 536 {Buildings & Roads-III}/2023 issued vide letter No. 62/C-III/Enlistment/ADG/SE(SE (W&TLQA)/424/2023-24/8480 dated 27.09.2023.

Whereas, Shri Naseem Ahmad was a partner of both M/s IDN & Sons and M/s Aayan Construction Company, as per the above enlistment orders. Therefore, M/s IDN & Sons has violated Rule 6.1.3 of "Rules for Enlistment of Contractors in CPWD."

Whereas, as per Rule 13.6 (c) of the "Rules for Enlistment of Contractors in CPWD 2024", the contractor may be debarred if any of the following is established by enquiry:

(c) fails to abide by the conditions of enlistment;

Whereas, a Show Cause Notice was issued to M/s IDN & Sons vide letter no. 25(13)/ADG(PD)/B&R/C-II/2024/1641 dated 29.04.2025 and even No. 1944 dated 16.05.2025. Shri Naseem Ahmad partner in M/s IDN & Sons has submitted the reply to the show cause notice vide letter No. Nil dated 21.05.2025 (received through email dated 22.05.2025).

Whereas, the reply submitted by M/s IDN & Sons has been considered carefully by the Enlistment Authority.

After carefully considering all the facts & circumstances of the case and the reply submitted by M/s IDN & Sons, the Enlistment Authority hereby debars M/s IDN & Sons from tendering in CPWD Works for a period of **Six Months** from the date of issue of this order.
