### **OFFICE ORDER No. 11/2021**

**Sub:- Cancellation of Enlistment Registration under Class-V(Building Category, formerly, Civil Category)Contractor in CPWD in r/o M/s Pruthvi Constructions, Ananthapur**

- a. Chief Engineer-Vijayawada, CPWD, Vijayawada vide Lr. No. 31(2)/2020/CE(Vijayawada)/409(H) dated 21.01.2020 has requested to take necessary disciplinary action against M/s Pruthvi Constructions (Sole Proprietor, S. Prathapa Reddy), Door No.13-2-240, Rama Chandra Nagar, Ananthapur-515 001, Andhra Pradesh, consequent upon identifying forgery and falsification of award letter issued by Executive Engineer, Tirupati Project Division, CPWD, Tirupati for the work of Construction of Impliment cum Training shed for SRFMT & TI, Garledinne, Ananthapur, Andhra Pradesh, Agreement No. 06/EE/TPD/e-Tender/2014-15.
- b. Whereas, M/s Pruthvi Constructions (Sole Proprietor, S. Prathapa Reddy), Door No.13-2-240, Rama Chandra Nagar, Ananthapur-515 001, Andhra Pradesh, were registered in Class-V(Civil) category contractor in the whole of South Zone, Central Public Works Department, vide office order F. No. 12(58-A)HCC.I/2014/4236-47(H) dated 30.09.2014, for a period of 5 (Five) years. The above order stipulates that the agency is bound by the Enlistment Rules of CPWD as amended from time to time.
- c. Whereas, as per the condition under Para No.30 of the aforesaid enlistment order and as per Para No.23.3 of Enlistment Rules, 2005(updated Enlistment Rules, 2019 as well as 2020), the enlisted contractor shall not indulge in any type of forgery or falsification of records, which will render his enlistment for cancellation from list of CPWD enlisted contractors.

d. A Show cause notice was issued by this office vide Lr. No. 16(V)/ADG-RH/CPWD/2020/787-88(H) dated 14.02.2020 and a reminder was issued vide even Lr. No. 1203-04(H) dated 12.03.2020 that why disciplinary action should not be taken against you and why you should not be removed from the list of enlisted contractors of CPWD, for which no reply was received from the agency inspite of giving sufficient time and opportunity.

e. Having received both the above letters of notice, giving fair & reasonable opportunity to the agency, the agency had not replied at all, thereby admitting the fact that the agency had tampered government records.

f. The issue was placed before empowered Committee, who in its meetings held on 07.01.2021 after due deliberations and by considering the facts on records has found that M/s Pruthvi Constructions, Ananthapur has committed wrongful action of forgery and falsification of award letter issued by Executive Engineer, Tirupati Project Division, CPWD, Tirupati.

g. Now, Therefore, in terms of the provisions contained in Para No.23.3 of Enlistment Rules,2005(updated Enlistment Rules,2019 as well as 2020), the Enlistment Authority i.e., Additional Director General, Region Hyderabad, CPWD, Hyderabad is pleased to remove the name of M/s Pruthvi Constructions (Sole Proprietor, S. Prathapa Reddy), Door No.13-2-240, Rama Chandra Nagar, Ananthapur-515 001, Andhra Pradesh from the approved list of Class-V(Building Category, formerly Civil Category) Contractors in CPWD with immediate effect.

**OFFICE ORDER**

With reference to His/ their application the Superintending Engineer, Hyderabad Central Circle No.I, Central Public Works Department, Hyderabad is pleased to **enlist** the following contractor in **Class V ( CIVIL ) Category** of this Department. He/they shall be eligible to tender for CPWD Works in the above category in the South Zone. II for a period of **5 (five) years** mentioned against his/their name and address without prejudice to the rights of the Department to prescribe / modify the limits of tendering. This is also subject to his meeting the eligibility criteria as laid down in the DG's O.M. No.DG/MAN/ 228 dated 27.09.2010 read with DG's O.M.No. DG/MAN/ 228 A dated: 25.02.2011 or any further amendments thereof made from time to time without prejudice to the rights of the department to prescribe / modify the limit of tendering.

14. He/They shall apply for revalidation of his enlistment in the prescribed form along with all required documents so as to reach the enlistment authority at least ( 6 ) Six months before the expiry of the enlistment.
15. He/They shall be eligible to submit tenders for Civil works up to a limit of **Rs.15 lakhs (Rupees Fifteen lakhs only)** in the whole of Southern Zone II where the Central Public Works Department has its Organisation.
16. (a) He/They shall be required to deposit the earnest money with each application of tender as per the terms and conditions of the Notice Inviting Tenders.  
 (b) Security Deposit will be recovered from the bills in accordance with the rules in force from time to time.
17. He/They will employ the required technical staff and tools & plants as per the terms and conditions of the each contract / agreement.
18. The enlistment of a contractor in CPWD shall only entitle him to be considered for issue of tender papers subject to the conditions laid down in each individual NIT. It shall not confer any right on him either to be necessarily issued the tender papers or for award of work. He shall have to abide by the terms and conditions of the NIT / Contract / Agreement as it stands or as may be altered from time to time.
19. He shall not modify the existing constitution or enter into any fresh partnership without prior approval of the Department. In case he wishes to change the constitution, he must submit in advance along with full details as required. Any change in status of the contractor as an individual without prior approval of the enlistment authority will render the contractor liable to be removed from the approved list of contractors.

26. He shall not be permitted to tender for works in Central Public Works Department/ Circle ( responsible for award and execution of contract ) in which his near relative is posted as Divisional Accountant or an officer between the ranks of Superintending Engineer and Junior Engineer ( both inclusive ). He should also intimate to this office the names of persons who are working with him in any capacity or are subsequently employed by him and who are near relatives of any Gazetted Officer in Central Public Works Department or in the Ministry of Urban Development. Any breach of the condition by the Contractor shall render him liable to be removed from the approved list of contractors of the Department.
27. He should also intimate the change in his address ( Registered Office / Head Office ), if any, in advance or maximum within One month of such change along with acknowledgement of noting down of such change in address from the Bank, Income Tax, Sales Tax authorities etc.,. In case, he fails to intimate the same to the Department, he shall render himself liable to be removed from the approved list of contractors of this Department.
28. He is required to secure at least two works of appropriate magnitude in this Department and at least one of them must have been completed 100 % and the second work by more than 50 % ( or ) as an alternative the contractor should have completed one work of value 1.5 times the minimum appropriate magnitude. If he secures only one work of appropriate magnitude during the last enlistment period and that even not completed shall be extended for a period of two years and balance period of three years shall be granted, only when the contractor satisfies the eligibility criteria. In case, he fails to secure works of specified magnitude during the period of registration, the registration of the contractor is liable to be not revalidated.
29. In case he fails to secure one work of appropriate magnitude during the validity period of his enlistment, he is allowed to submit fresh application for enlistment if he fulfills all the eligibility criteria and provided he has participated in tendering process in CPWD but remained second or third lowest on more than 2 occasions during the validity period of his enlistment.
30. He shall be bound by the Enlistment / Revalidation rules of the Department as amended from time to time.
31. The Revalidation of enlistment shall be open to review by the enlistment authority and liable to termination, suspension or any other such action at any time if considered necessary by the enlistment authority.
