# Tour note of Shri Ram Muivah, JS & CVO to Shillong, Meghalaya from 13th to 15th June, 2008.

- 1. During my official tour programme to Shillong (Meghalaya) from 13th to 15th June, 2008, I have reviewed the following vigilance cases:
- (i) Shri S.C. Bora, AE(E) Retd. on 31.12.2000

CBI raided his house and office on 27.07.1996. It was reported that the case is under process in the court and next date of hearing is on 20.06.2008.

(ii) Shri Kamala Kanta Das, Divisional Accountant Retd. on 31.07.2003.

The charge sheet was served by the CCA, Ministry of UD on 15.10.2001. The decision of CVC 2nd stage advice was communicated to Shri K. Das on 12.04.2004 stating that Commission would advice sitable cut in pension of Shri K.K. Das. Shri K.K. Das submitted his representation on 11.5.2004. Now the case has been forwarded to UPSC for final decision.

(iii) Shri D. Bhattacharya, Executive Engineer(E) P&A, GCEC.

Case is related to allegation of misuse of official powers by CPWD officer in NE Region (Electrical Wing) during the tenure of Shri M.K. Verma, SE(E) and Shri Ved Prakash, EE(P&A) (Now retd.) in GCEC. During the period, Shri D. Bhattacharya was posted as EE(E), SCED, Silchar. It was reported that the documents sought by the vigilance unit were sent to Vigilance Unit in the months of August, 07 & October, 07. The reply to the O.M. issued by SE(E)Vig. CPWD was sent by Shri D. Bhatacharya, EE(E) in the month of Dec.07. No further communication was received.

(iv) Shri S.S. Sahoo, AE(E) & Shri S. Bhowmik, JE(E)

A surprise check was conducted by CBI team on 17.7.2006 at sites at GPRA & AG Colony, Motinagar, Shillong and report was sent to

## **Present Status:**

The above work was inspected by me on 14.06.2008 along with Chief Engineer (NEZ), Executive Engineer (planning), CPWD field staff and representative of construction agency. The foundation and footings are complete. For ensuring the quality of controlled concrete, mini batching plant having capacity of 15 Cum/hour is installed at site. This plant has controlled mixing in required proportion of water, aggregate, sand and cement. The progress of work is satisfactory.

#### 3. Other Issues:

During my interaction with Shri R.S. Sheoran, Chief Engineer, Shillong and Shri S.P. Singh, SE, Silchar, it was reported that the post of Executive Engineer Manipur Central Division is lying vacant for more than 3 years. CPWD was managing the same by giving additional charge of this post to another Executive Engineer initially Dimapur, Nagaland, later on Executive Engineer, Silchar ad currently Executive Engineer, Aizawl. However, this arrangement is now found to be not effective and the progress and quality of works of Manipur Central Division is suffering very badly. Of late Manipur Central Division has also been awarded some major projects under SAI. It may be recalled that the need for urgent posting of regular Executive Engineer in Manipur was also mentioned in my earlier tour note of April, 2007. Unfortunately till date no regular Executive Engineer appears to have been posted to Manipur Central Division. It is suggested for immediate posting of a regular EE(C) in Manipur Central Division to cope with the work load of the Division.
