- 3. It was noted that all the decisions taken in the meeting held on 21st February, 2007 have been attended except decision No.10 regarding the visitors' room for inspection of records by SPS/COs. DG expressed his concern over the delay and desired that the matter may be taken up with Vigyan Bhawan Circle for expeditious implementation.
- 4. DG(W) enquired about the stage of cases where maximum delay in investigation of the cases. It was reported by the CVO that the collection of records/reports from various officers takes maximum time. It was decided that the proposal may be initiated by CVO to ADG(TD) and such cases pertaining to various Zone may be discussed in Senior Officers Conference.
- 5. It was observed by the DG(W) that many complaints, after verification, turned out to be false. In such cases the motive of the complainant is to harass the public servant. What suitable action against complainant can be taken if such complaints turned out to be false after verification, be examined.
- 6. In the meeting the target for the next 6 months were drawn up (Annexure-I).
- 7. The above target has also been sub-allocated for the SE(V)I/SE(V)II/SE(V)El. and all EEs(V) & EOs(D) (Annexures II, III & IV).

- 8. It should be the endeavor of everyone concerned to achieve the targets as the same will be reflected in the ACR.
- 9. DG(W) mentioned ICRA report commissioned by Ministry some years ago where some suggestions for "softer mechanism" for vigilance procedures was recommended. He desired that we may examine implementing the recommendations of the ICRA.
- 10. DG(W) desires that in future notes/orders etc. requiring his signatures only may be put up to him in separate folders for signature only rather than sending with entire files.

- 1. Shri A. Chakrabarti, DG(W), took a review meeting of the vigilance cases in CPWD on 03.07.2007 at 11.30 A.M. in his chamber, and the following were decided.
- 2. All decisions taken in the meeting held on 3rd May, 2007 had been attended. DG(W) reviewed the progress and achievements of the first quarter vis-a-vis the target for the next 2 quarters. Regarding the complaints DG(W) desired that pendency of the complaints received as on 1.4.2007, received upto 30.06.07, disposal during the period be intimated to him. He also desired that similar exercise may be carried out for the cases pending finalisation of investigation report.
- 3. The DG(W) expressed his concern particularly regarding finalisation of interim investigation report, calling explanation memos and final investigation report where achievement in the quarter April-June, 2007 was on the lower side. He desired that by the quarter ending September, this deficit needs to be patched up.

- 4. DG(W) also desired that case study of a few sample cases bringing out the time taken for their disposal from the stage of receipt of complaint till issue of final orders be submitted to him. There is a need to find out the stages where the delay takes place in disposal of the cases and to sort it out. DG(W) emphasizes the need of making a presentation of the case study during the next Senior Officers' meeting on 12th July,2007 with a view to delav in of highlight the submission the information/report/record which results in delays of disciplinary cases thereby affecting the career prospect of the charged officers.
- 5. It was intimated by CVO that after various references were brought to the notice of the Chief Engineers in the last Senior Officers' meeting, the records/reference had been received. DG(W), in turn, desired that the cases where information/records are yet to come from various Zones may be identified and a reminder may be sent to them by 5th July, 2007 so as to enable them to expedite the matter before next Senior Officers' meeting scheduled on 12th July, 2007.
- 6. During the review it was transpired that the cases sent to the Ministry where final orders to be issued with some penalty takes quite sometime in obtaining the advice of UPSC. It was desired by DG(W) that all such cases thus have been referred to Ministry for passing the final orders may be identified and request may be made to Ministry, so that career prospects of the charged officer are not affected on account of delay.

- 7. DG(W) observed that in one of the recently concluded case, an SE as a disciplinary authority, has imposed a penalty not commensurate with the gravity of lapses. It was felt that there is an urgent need to enlighten the officers regarding vigilance matters, particularly the SEs who have to act as disciplinary authorities in cases of Group 'C' officers. He desired that a Workshop may be organized at CPWD Training Institute, Ghaziabad, in consultation with ADG(Training). SEs of Delhi region may be asked to attend the course. One similar Workshop per quarter may be organized for SEs of other regions in forthcoming quarters.
- 8. As part of preventive vigilance, it was decided that a <u>vigilance bulletin</u> may be published quarterly to strengthen vigilance awareness by bringing out inter alia, case study of recently concluded cases.

1. The performance of $\mathbf{SE}(\mathbf{V})\mathbf{I}$ was found wanting on the following:

He has disposed only one **IIR** against the target of 8 Nos. He has issued only 2 **Explanation Memos** against the target of 9 Nos. No **charge sheet** has been issued against the target of 4 Nos.

2. The performance of **SE(V)E** was found wanting on the following:

He has disposed only 3 Nos. of IIR against the target of 12 Nos. issued 5 **explanation memos** against the target of 15 Nos., and finalised 5 **Investigation Reports** against the target of 22 Nos.

- 3. The performance of the following Executive Engineers are found to be poor in respect of the following:
- (i) **EE(V)IX** has not disposed a single IIR till now against the target of 5 Nos. **EE(V)II & IX**, have issued only one Explanation Memo No. each against the target of 6 & 3

respectively. **EE(V)II** has finalised only 2 IRs against the target of 7 Nos. Both the Executive Engineers have not issued a single **Charge Sheet** against the target of 2 Nos. each. In respect of appointment of IO/PO, the performance of EE(V)II is nil. Regarding Comments on CO's representation, the EE(V)II has finalised only one till date.

- (ii) **EE(V)V** has not finalised a single IR against the target of 3 Nos.
- (iii) **EE(V)VII**, has not finalised a single IIR against the target of 3. He has also not finalised a single IR against the target of 3. He has also not finalised a single **Charge Sheet** against the target of 2.
- (iv) **EE(V)XI** has not finalised a single IR against the target of 3. He has also issued only one **Charge Sheet** against the target of 8.
- (v) **EE(V)I** has not issued a single **Charge Sheet** against the target of 4. **EE(V)III** has finalised only 2 IIRs against the target of 5. 6. - 1. The annual target vis-à-vis achievement till date of investigation cases, disciplinary cases, CAT/Court cases were reviewed by DG (W) CPWD. He expressed his satisfaction regarding achievement of investigation cases. However regarding the shortfalls in disciplinary cases, it was explained to him that the main reason was the non-posting of two EO(D)'s in the Vigilance unit since November 2007.
- 2. The various pending references made by Vigilance Unit with various regions was reviewed by DG (W) with reference to the target dates committed by various Regional heads/Zonal heads in the Senior Officers Meet held on 28.1.2008, 30.1.2008, 31.1.2008, 1.2.2008 and 12.2.2008.

In four cases where ADG (TD) had committed the target date on or earlier to 18.2.2008 for making the records available, target were not met with.

In a case pertaining to CE (NDZ-I) where detailed comments were to be offered by CE (NDZ-I), it was committed by him that he would hold meeting on 12.2.2008 to sort out the bottlenecks. The outcome of the meeting or any target date for sending the comments has so far not been communicated by him.

CE (EZ) II has to submit certain details relating to CTE inspection of two works for which a target date was committed by him was 19.2.2008. The details are yet to be received from him.

ADG (WR) had committed a date of 15.2.2008 to submit the records/report relating to the complaint against Dr. N.K. Sharma, DD (Horticulture) which is still awaited.

ADG (NR) and CE (E) NZ has committed a date of 18.2.2008 for submitting record/report on a complaint relating to Public Interest Disclosure Resolution. The same is still awaited.

The DG emphasized that the CEs should make all efforts to adhere to the target dates committed earlier.

- 3. CVO, CPWD reported about the Vigilance Audit of Division M233 of PWD (NCTD). He also elaborated the issues forming basis of the Vigilance Audit. DG (W) advised that the main thrust of such Vigilance Audit should be systems and procedures rather than the quality aspect of the work as quality audit is regularly being carried out by SEs (QA) of various Regions. Such a presentation would give a clear picture about increase/decrease of pendecy and rate of disposal of the cases.

- 2. Vigilance referencees pending with various Zones were reviewed by DG (W). He suggested that reminder should be issued by CVO where the information is not forthcoming. In case it is essential, DO reminders from DG (W) may also be sent. It was further suggested by DG (W) that CVO should also call the Zonal Heads in person to sort out the bottlenecks and to minimize the delay in obtaining the desired report/records.
- 3. The New guidelines regarding grant of vigilance clearance to members of the Central Civil Services / Central Civil Posts issued by DoPT under their OM dated 14/12/2007 were deliberated. The said circular uses the word 'normal' at places thereby leaving ambiguity in interpretation of

the guidelines contained in the said OM. DG (W) suggested that clarification may be obtained from DoPT regarding implementation of the directions in the said OM. For the purpose, Vigilance Unit may make a reference to CE (P&S) who in turn will refer the matter to DoPT.

- 4. Recommendation of ICRA, earlier suggestions of the Directorate in this regard and the communication received from CVC regarding formation of two committees before launching vigilance action was deliberated in detail. In the review meeting, DG (W) suggested the constitution of committee to be formed for the cases pertaining to officers of various levels. In this regard, a separate note will be put up to him for approval.
- 5. Shortage of vehicle was also discussed in the review meeting. DG (W) decided that a hired vehicle will be provided to the Unit by Superintending Engineer (Vigyan Bhawan).
