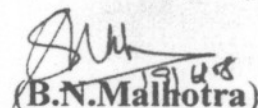

The Office Order no. 144/2008 which was issued vide even No. dt. 22/5/08, is modified as under

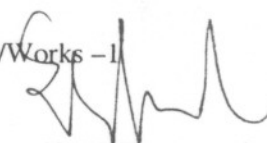
