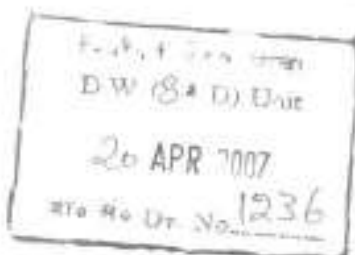

Sir,

The National Security Guard urgently requires the services of JEs (Civil / Elect.) on deputation basis to fill up the existing vacancies as under:-

AC-I/II (JE/CIVIL/ELECT.)  
Pay Scale: Rs. 6500 - 10500 /  
Rs. 5500 - 9000

02 posts of AC(Civil) &  
06 posts of AC (Elect.)

2. As per the Recruitment Rules notified, these posts are to be filled by transfer on deputation from amongst the personnel holding analogous posts on regular basis and having two years working experience in the relevant field. The age of personnel should not exceed 45 years as on 31/05/2007 and should be medically fit.

3. Personnel while on deputation with the NSG would continue to draw the basis pay being drawn by them in their parent department and would be entitled to the following pay and allowances:-

- Basic pay/DA as admissible in the scale of pay of the rank held in the parent organisation.
- Other allowances admissible to the Central Govt. employees from time to time.
- NSG allowance @ 25% of total emoluments(excluding HRA and CCA).
- Concession of free ration according to Army scale and rent free unfurnished family accommodation or HRA plus CILQ at the rates sanctioned from time to time.

4. It is, therefore, requested that nominations of willing and suitable personnel may please be sent to this HQ alongwith their Service Books and CR dossiers by 31.05.2007.
