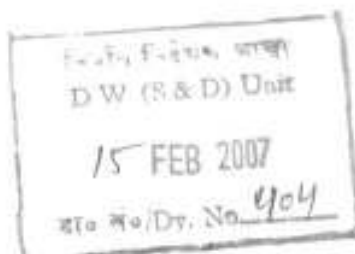

The Phase-II of Delhi Metro comprising about 120 kms. is to be completed before the Commonwealth Games slated for October 2010 and we are facing acute shortage of officers at AEN/XEN level. We are in urgent need of about twenty (20) AEN/XEN level officers of civil engineering discipline for posting on deputation basis.

The officers should be in Jr. Scale/Sr. Scale for a minimum of three years and should be below 40 years of age. Those Jr. Scale officers who have put in a minimum of 5 years service in officers' cadre will be eligible for grant of next grade in DMRC. Sr. Scale officers, however, will be eligible for deputation in the same grade.

Besides, we require twenty-five (25) non-gazetted, civil engineering/supervisory staff, on deputation. The staff on joining DMRC will be given a grade higher, subject to a maximum of Rs.7500-12000 or the deputation allowance.

I shall be grateful if the above vacancy position is circulated among willing and eligible officers/staff and the list of willing personnel sent to us early.
