Sub: Delogation of enhanced powers to the Officers of CPWD engaged for execution of works of emergent nature.

Para 2.3 of manual vol. II stipulates the execution procedure for urgent and emergent works.

For executing works of such urgent and emergent nature, the enhanced powers to the officers of CPWD have been delegated by Ministry of UD vide their No. 19011/90/2001/DS(W) dated 17.1.2001(copy enclosed) The enhanced powers will be utilised only in respect of works of emergent nature.

The delegation of powers will continue subject to restriction and powers contained in various Government orders issued from Ministry of Finance from time to time.
